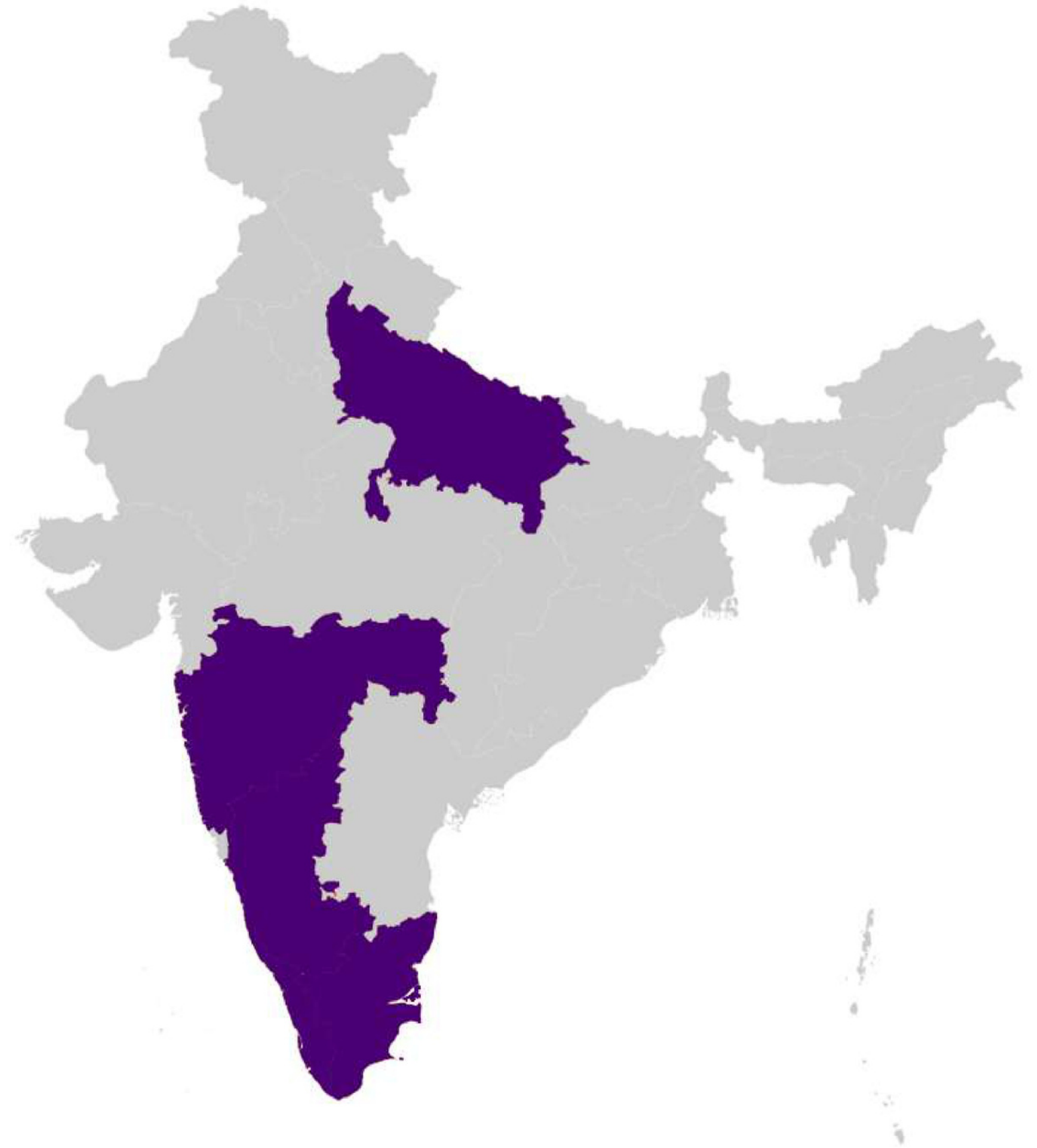



# Cut-off dates for ICSI Exam/Registration

- For appearing both groups in December exam register on or before 31st May.
- For appearing single group in December exam register on or before 31st July.
- Exam fees for December exam to be paid on or before 25th September.
- For appearing both groups in June exam register on or before 30th November.
- For appearing single group in June exam register on or before 31st January.
- Exam fees for June exam to be paid on or before 25th March.
- Exam registration to be done @ <https://smash.icsi.edu/scripts/login.aspx>
- Pre-test can be done on or before 25th March/25th September @ <https://g25.tcsion.com/LX/login#lx> using login ID: registration number@icsi.edu (without backslash); password as received in the registered mail ID
  - **Group 1 Exam starts on December 21 / June 1 and continues on alternate days, Excluding Sundays**
  - **Group 2 Exam starts on December 22 / June 2 and continues on alternate days, Excluding Sundays**
- On completing both groups of CS Professional, students shall complete 15 days offline Corporate Leadership Development Program (CLDP) at the nearest chapter and 15 days E-CLDP online.

# Training

- CS Executive students shall complete One Day Orientation Program (ODOP) on or before 25th March/25th September at the nearest chapter.
- On completing both group of CS Executive, student shall complete 15 days offline Executive Development Program (EDP) at the nearest chapter and 15 days E-EDP online.
- On completing both group of CS Professional, student shall complete 15 days offline Corporate Leadership Development Program (CLDP) at the nearest chapter.
- 21 months Training agreement shall be executed in the stamp paper and registered @ <https://stimulate.icsi.edu/>
- Alternatively person having 3 years of work experience in the relevant sector can claim exemption.
